ENACTED BY THE PARLIAMENT OF TUVALU

Commencement: 21st December, 2017

1 Short Title

This Act may be cited as the Supplementary Appropriation Act 2017.

2 Authorisation of Expenditure

The Minister may by warrant under his hand, in addition to the sum hereby authorised for the service of Tuvalu for the Financial year ending 31 December, 2017, further authorise the issue from the Consolidated Fund for the service of the same Financial Year a sum not exceeding seven hundred and fifty thousand dollars


